



LIABILITY RELEASE FORM

I, _____ (Client Name) being 18 years of age or older, do for myself (and for or on behalf, as guardian of my child participant, if said child is not 18 years of age or older) do hereby release, forever discharge and agree to hold harmless East Cape Guides (Fishing Guide), Booking Agents, Activity Vendors and the directors thereof from any and all liability, claims or demands for personal injury, sickness or death, as well as property damages and expenses, of any nature whatsoever which may be incurred by the undersigned and/or the child participant that occur while said is participating in the above described trip or activity.

I (and for or on behalf, as guardian of my child participant, if under the age of 18 years) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein. Authorization and permission is given to said trip and travel organizer to furnish and hereby release liability of transportation, food and lodging for the Client.

The undersigned further hereby agrees to hold harmless and indemnify said organization(s), its directors, employees and agents, for any liability sustained by said travel organizer as the result of negligence, willful or intentional acts of said participant, including expenses incurred attendant thereto.

(If the participant has not attained the age of 18 years):

I am (we are) the parent(s) or legal guardian(s) of this participant, and hereby grant my (our) permission for him/her to participate fully in said event and hereby give our permission to take said participant to a doctor or hospital and hereby authorize medical treatment, including but not limited to emergency surgery or medical treatment, and assume the responsibility of all medical bills. Further, should it become necessary for the participant to return home due to medical reasons or otherwise, I (we) hereby assume all transportation costs.

It is my responsibility to read and acknowledge the follow policies:

Reservations

East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent for any reservations made by the Client. The Client is responsible for confirming all reservations and payment of deposits, flight tickets, transfers, hotel accommodations, boat charters, food/beverages, fishing license, fish processing, bait and tips.

Payments

All guiding fees must be paid in full 24 hours before guide services are rendered. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent for payment of deposits, flight tickets, luggage fees, transfers, hotel accommodations, boat charters, food/beverages, fishing license, fish processing, bait and tips.

Guarantees

East Cape Guides (Fishing Guide) will not provide the Client with any guarantees as to the availability of fish species for the Client to catch. East Cape Guides (Fishing Guide) will not assume responsibility for lost fish by the chartered boat or the hotel. The Client is responsible for all fish landed and any costs incurred from fish processing including filleting, vacuum sealing and transport.

Transfers

The Client assumes all responsibility in reserving and payment of transfer services. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent in the reservation, deposit or payment of transfer services to and from the airport or any other destination. East Cape Guides (Fishing Guide) will not assume responsibility for any unavailability of transfers or late arrivals. All transfer services are owned and operated by an independent operator.

Hotel Accommodations

The Client assumes all responsibility in reserving and payment of hotel accommodations. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent in the reservation, deposit or payment of hotel accommodations by the Client. East Cape Guides (Fishing Guide) will not assume responsibility for any unavailability of hotel accommodations. All hotel accommodations are owned and operated by the hotel.

Boat Charters

The Client assumes all responsibility in reserving and payment of charter boat services. East Cape Guides (Fishing Guide) will not provide the Client with any guarantees on the availability of boats and/or boat crews chartered by the Client. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent for reservation, deposit or payment of boats and crews chartered by the Client. East Cape Guides (Fishing Guide) will not assume responsibility for any unavailability of boats and/or boat crews chartered by the Client due to boat malfunction, captain/crew and/or weather. All boats are owned and operated by the hotel or an independent operator.

Boat Malfunction

East Cape Guides (Fishing Guide) will not provide any guarantees as to the working operations of a Client chartered boat or assume responsibility for any boat malfunctions before or during a Client's chartered fishing trip. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent for any refunds from the hotel or boat charter services due to boat malfunctions or unavailability. All boats are owned and operated by the hotel or an independent operator.

Weather

East Cape Guides (Fishing Guide) will not provide any guarantees as to the weather on a Client's fishing trip or assume responsibility for any foul weather during your trip. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent for any refunds from the hotel or boat charter services.

Guided Fishing

East Cape Guides (Fishing Guide) services for a single exclusive fishing day are limited to 7am to 3pm. East Cape Guides (Fishing Guide) is not responsible for the decisions and/or destinations chosen by the charter boat captain/crew. The final decision on fishing destinations is made by the captain.

Photography and Videography

I grant permission to East Cape Guides (Fishing Guide), and its agents, employees or assigns, the irrevocable right to use the photographs and video footage taken by East Cape Guides (Fishing Guide) for use in any East Cape Guides (Fishing Guide) publication such as advertising, direct mail, brochures, newsletters, and magazines, and electronic versions of the same publications or on websites or other electronic media. I also grant permission to the East Cape

Guides (Fishing Guide), its agents, employees or assigns to offer the identified photographs for use or distribution in other publications, electronic or otherwise, without notifying the Client. I hereby waive any right to inspect or approve the finished photographs or printed or electronic matter that may be used in conjunction with them now or in the future, whether that use is known to me or unknown, and I waive any right to royalties or other compensation arising from or related to the use of the photographs.

I hereby agree to release, defend, and hold harmless the East Cape Guides (Fishing Guide) and its agents, employees or assigns including any firm publishing and/or distributing the finished product in whole or in part, whether on paper or via electronic media, from and against any claims, damages or liability arising from or related to the use of the photographs or video footage, including but not limited to any misuse, distortion, blurring, alteration, optical illusion or use in composite form, either intentionally or otherwise, that may occur or be produced in taking, processing, reduction or production of the finished product, its publication or distribution.

Illegal Drugs

Sickness, Bodily Injury, Property Damage and Death

East Cape Guides (Fishing Guide) will not assume responsibility for any sickness, bodily injuries, property damage, death and/or dismemberment incurred by the Client while en route to or at a destination, including all charter boat trips. East Cape Guides (Fishing Guide) will not assume responsibility for heat related illnesses, food/beverage related illness and/or seasickness. East Cape Guides (Fishing Guide) will not assume any responsibility or act as an agent for any refunds from the hotel or boat charter services due to illness.

Medical care and medical facilities may not be readily available and may not meet the standards expected in the United States. To the best of my knowledge my health is good enough to undertake the trip. If I have any question about my health, I will visit my physician and discuss this trip before departure. I understand that I will be traveling to places where little to no health care will be available. In addition, I understand that I may undergo types of exertion that I am not used to. It is my responsibility to maintain a current knowledge of travel advisories, medical advisories or other risks until my departure, while I am traveling and at my destination.
